

# CALL FOR EXPRESSION OF INTEREST FOR THE MANUFACTURE AND SUPPLY OF MATERIAL FOR CLEAN WATER PRODUCTION AND DISTRIBUTION: ON ORDER BASED PROCUREMENTS

## 1. Object

REGIDESO launches an International Call for Expression of Interest toward manufacturers of materials for the production and distribution of clean water.

The full technical requirements and details (price, quantity, etc...) shall be defined in the technical clauses and included in the Bills of Quantities (BOQ) and prices of the Bid documents in the course of ordering.

## 2. Types of material

- ▶ Water pipes and their corresponding accessories (ductile iron, PVC, etc.) ;
- ▶ Water meters and their corresponding accessories (classic, prepaid, etc.);
- ▶ Chemical products for water treatment;
- ▶ Equipment for pumping water; (motor pumps and control board/cabinet).

## 3. Financing

The project is 100% financed by REGIDESO through its own funds.

## 4. Participation requirements

Participation in the Expression of Interest process is equally open to any physical or moral bidder that manufactures materials for the production and distribution of clean water, from all the countries across the globe, provided the interested Bidder/Manufacturer demonstrates his legal, financial and technical capabilities required for the manufacturing and supplying of the aforementioned materials.

Any Bidder concerned by one of the incapacity rules stated in Article 161 of the Code of Public Biddings in force in Burundi since January 29th 2018 is not eligible for bidding. It should also be noted Non-Profit organisations are not eligible for these Bids. International Bid documents will be submitted only to prequalified Bidders/Manufacturers and under the conditions defined in aforesaid Bid documents.

## 5. Presentation and submission of Expressions of Interest

submitted at the Headquarter of REGIDESO on 04/12/2018 at 9:30 AM (local time). Each and every interested Bidder/Manufacturer shall prepare one (1) original and four (4) copies of his Expression of Interest, clearly indicating on hard copies "ORIGINAL" and "COPIE".
